Further this is to inform you that as per the SEBI (Prohibition of Insider Trading) Regulation, 2015 as amended from time to time and the Company’s Code of Conduct to regulate, monitor and report the trading of equity shares, the Trading Window for dealing in the securities of the company by the designated persons and their immediate relatives of the company has been closed from today i.e. Wednesday 25<sup>th</sup> February, 2026 and shall remain closed till 48 hours from the closure of the Right Issue Committee Meeting.
